# Message from Artistic Director Michael Bennett

It goes without saying that this season was like no other in the history of our organization. Our 55th season, *A Season of Splendor*, met that standard in so many ways, despite being abbre-



viated. While we will remember this season as the one ending in a pandemic, there were also many bright moments. We began the season continuing to connect with our organization's history, with the LMC performing one of the greatest works — *Magnificat* — of J.S. Bach. I also remember the special way that concert ended, with our Platinum Circle members joining in the singing of a few chorales of Bach.

The Lafayette Children's Choir had a very busy fall, preparing for two performances in a matter of just a few weeks. The Indiana Voices in Song festival brought together children's choirs from all over Indiana. It was especially wonderful to have former LCC director Denise Gilliland conduct the festival. Just two weeks later, all LCC ensembles performed their fall concert, *All Things Bright and Beautiful*, featuring music celebrating nature and life.

What was planned as the "blockbuster" concert of the LMC season also turned out to be the end of it from our patrons' perspective. For the first time in 10 years, the LMC performed Handel's *Messiah* in full. With a capacity crowd at St. Boniface just days before Christmas, we gave this community a very special gift. This performance of the LMC was by far their best given in many years, and although unplanned, was the best possible "end" to our 55th season. Rehearsals of the LMC and LCC resumed on schedule in January, but our final concerts were, unfortunately, unable to occur.

The LMC received several new singers throughout the year. This is wonderful musically and for expanding our audience base. In addition, a few of our members either retired or moved away. Our audience attendance was again higher this season, continuing the steady climb since 2014-15.

I would like to thank many people who make this work so special to me: Charles Manning, our invaluable accompanist; Marcy Miller, board president; Cindy Gerlach, managing director; Colleen Green and Kirsi Seagraves, who work so lovingly with our children's choirs; and Karen Goff, my constant rock of support, encouragement and steadiness. Thank you all for your dedication to our organization's mission of promoting, educating, enriching, leading and inspiring our community through the art of choral singing.

#### **Annual Meeting**

Bach Chorale Singers, Inc. June 12, 2019 Tippecanoe Arts Federation

The annual meeting of the Bach Chorale Singers Inc. was called to order at 6:30 p.m. by President Marcy Miller at the Tippecanoe Arts Federation Building. In attendance were the following board members, singers, staff and interested individuals:

Miller asked everyone to review the annual report, thanking Donna Peterson for her efforts preparing the report. With the exception of changing Karl Brant's name from a C to a K, the minutes from the previous year were approved.

The following reports were given: John Polles gave a special thank you and recognition to Jack Gaunt, a retiring singer, for the time he has given to the organization since 1972.

**Membership** Polles reported the membership incudes the Bach Chorale Society as well as donors, singers and parents.

**Business/Finance** Bill Lapcheska reported a positive year, and as a result the budget was increased by 12 percent. The surplus has been attained thanks to the work of the following:

- Donna Peterson, Rick Lodde and Mark Hermodson for doubling the sponsorships
- Michael Bennett for careful management of the concert budgets
- Kay Connor for a successful Phone-a-Thon
- Joe Vanable for efforts on advertising

Lapcheska announced Vanable will be stepping down next year and others need to fill the large gap created by his absence. Lapcheska also announced there will be another estate-planning seminar in the fall.

**Lafayette Children's Choir** Attendance in the LCC is down, but it is felt the members are more committed. There are now 73 members. The organization is planning a search to find a replacement for Leeann Starkey, who is leaving to spend time with her family.

Marketing Cindy Gerlach reported the committee is preparing for next season.

**Development** Joe Vanable shared with the group that ads are down but sponsorships are up. This group will need help, and everyone is asked to consider getting involved.

**Donor Relations** Karl Brandt reported that thank you letters are a nice touch to send to the 151 donors.

**Treasurer** Rick Lodde reported the organization has a positive cash flow and is looking at investments for the future. The budget is in check because of the quality product the organization offers.

**Nominating** The board is made up of 21 board members. This includes past members as well as new board members. There is currently an open slot for a parent from the Lafayette Children's Choir. New members include Gail Brickler (Centier Bank) and Beth Dana. Brian Allinder made a motion to accept the new members, seconded by Vicki Bower. With no nominations from the floor, the motion carried.

**Artistic Director** Michael Bennett told the group the organization has been very successful, including the challenging Christmas programming. The Lafayette Children's Choir had a good season and is prepared to adapt to new leadership.

Bennett also reported that it has been 10 years since *Messiah* was presented. He feels with the current organizational structure, the timing is right to program this major undertaking.

**President** Miller was grateful to so many and gave a big thanks to the organization of volunteers.

**Resolution from the 2018-19 Board of Directors** Bill McInerney moved that: Be it resolved by the members of the Bach Chorale Singers, Inc., that the acts of the officers and Board of Directors of the Bach Chorale Singers, Inc., as reflected in the records of the corporation and as taken during the previous year be ratified, confirmed and approved, and that the officers and directors be thanked for their service during the past year. Marilyn Leigh seconded; motion passed.

Karl Brandt made a motion to adjourn the meeting, seconded by Rick Lodde. — Charlotte Gray, secretary

# A Season of Splendor



The Lafayette Master Chorale performed Handel's Messiah to a sold-out crowd at St. Boniface Church, Lafayette, on Dec. 21, 2019.

The 55th Season of the Lafayette Master Chorale was, in many ways, an homage to the beginnings of the organization. This year's chorale concerts hearkened back to traditional themes, with a fall performance titled *The Best of Bach*, and a planned spring performance of *Cathedral Classics*, which showcased great choral motets and anthems that have rung in glorious cathedral around the world, from Tudor anthems to modern hymn settings.

The chorale continues to grow and expand under the leadership of Artistic Director Michael Bennett, with nearly 60 singers joining the chorus this season. The small ensemble continued its outreach, under the direction of Emily Ohland, performing at various venues around the city, especially at the holidays.

#### Lafayette Children's Choir

The <u>Lafayette Children's Choir</u> this year welcomed a new co-director, with Kirsi Seagraves joining Colleen Green in directing the 55 children in three groups: Prelude Choir, Concert Choir and the Youth Chorus. Recruitment started at our teacher luncheon last summer, where area music teachers were invited to learn

about our program. In November, the LCC hosted Indiana Voices In Song, a day-long choral festival featuring songs by Indiana composers and arrangers. Six different regional choirs participated, performing their own repertoire and a finale that included all the choirs together under the direction of former LCC director Denise Gilliland. Five local schools also sent singers, bringing the total to 150 young choristers.

IVIS was followed by the LCC fall concert, *All Things Bright and Beautiful*, celebrating songs about the beauty of the natural world.

#### Staff Changes

This year saw some staff changes, most notably the departure of Donna Peterson, our long-time office administrator and book-keeper, who retired to spend more time with her family. Donna's years of service have been greatly appreciated, and we thank her for her many contributions over the years.

The board decided to restructure the position and in January brought in Cindy Gerlach with the title Managing Director. A local

journalist, Cindy was the Youth Chorus & Children's Choir coordinator in the early 2000s and has served on the Board of Directors since 2017. As Managing Director, her work will focus on marketing, development and donor relations, and fundraising. An outside bookeeper, Hannah Gibson, has been contracted to handle the bookkeeping tasks.

#### Marketing

The <u>Marketing Committee</u> continued to look for new ways to engage with our audience. They continued to use traditional forms of advertising, such as print ads and promotions on WBAA, Purdue's public radio station; Michael Bennett was always able to make time to visit with John Clare or Greg Kostraba just prior to our concerts. Younger audiences are sought out through use of social media platforms. For our biggest concert of the year,

*Messiah*, a promotional video was made, and the committee purchased a banner that hung for two weeks downtown, across Columbia Street.

#### Messiah

December brought about the pièce de résistance for the season: a production of G.F. Handel's full *Messiah*, with chorus and orchestra. It was the first performance of *Messiah* in Lafayette in 10 years. Thanks to a convergence of fortuitous factors — the timing, the appeal of Hanel's magnificent oratorio, the efforts of the marketing committee, and the caliber of the performance itself — a capacity crowd filled St. Boniface Church. The fabulous performance was appreciated by all.

And, as luck would have it, *Messiah* was the culminating performance of *A Season of Splendor*. Rehearsals were well underway for the chorale's *Cathedral Classics* and the LCC's *Road Trip U.S.A.* when the unforeseen outbreak of COVID-19

brought all activities to an unceremonious halt. Rehearsals, concerts and a planned donor recognition event were all abruptly canceled, with no plans to reschedule.

In so many ways, this season was shaping up to be one of our best in recent history. Despite having to cancel our final two concerts, the season ended on a high note, with cash on hand, thanks to vigorous ad sales and sponsorships, a successful Phone-a-Thon, careful spending by our Artistic Director and the board, a loan from the Payroll Protection Program, an emergency grant from the Indiana Arts Commission, and the generous support of our patrons. An early shutdown stunned us all — the entire world — yet the Lafayette Master Chorale & Children's Choir can look back on Season 55 and the stunning success of Messiah as A Season of Splendor, indeed.

# Message from Board President Marcy Miller

Much enthusiasm was generated with our three fall performances that began our 55th season, *A Season of Splendor*. Then, our *Messiah* concert drew a huge crowd and a fervent, appreciative audience. From a business and artistic standpoint, all was going very well for the Lafayette Master Chorale & Lafayette Children's Choir. We were looking forward to our final two concerts of the year, as well as a donor appreciation event. However, all came to a screeching halt in March as we faced the current COVID-19 crisis.

The performing arts sector has been deeply impacted by the pandemic. As we face new challenges, we have been forced to reexamine our mission and our goals while reorganizing our coming season. Decisions concerning our 56th season have been delayed. I greatly appreciate our directors, who remain adaptive and flexible, ready to move forward when it is safe to do so.

Not only does our staff exhibit dedication and talent at the highest level, but our board of directors is a vibrant and energetic body. Each member of our diverse board contributes unique abilities and talents. I would like to single out Cindy Gerlach for special recognition. Shortly after she began her position as managing director, we were dealing with the effects of the Coronavirus. With no official office hours or physical meetings, she has been the glue that holds our business functions together. Through her efforts we have also received additional funds.

Although the Lafayette Master Chorale and Lafayette Children's Choir have an uncertain immediate future, we remain firm in our commitment to the choral arts in our community. Because of our strong fiscal policies, we believe that we can weather this storm. Live performances will thrive in a post-pandemic society, and we will resume our standards of musical excellence. For now, we may need to explore new ways to reach our audiences. Our artistic director, Michael Bennett, continues to provide strong leadership during this time of adversity. His calm manner and steady professionalism ensure that our organization will maintain its prestigious place in the regional arts world. To our patrons and singers: thank you for your past loyalty. We ask for your help and support as we find our way back to our new normal.

# **Financial Report**

Despite the abrupt end to Season 55, the organization will finish the fiscal year with a slight cash surplus. Our performance of *Messiah* was funded with donations of several generous sponsors; thanks to the careful budgeting of the Artistic Director, the production came in under budget. Fundraising efforts (Phone-a-Thon in March), aggressive ad sales, and continued support of our donors leave us in good financial shape as we prepare for next season.
